Abstract (en)

[origin: WO2017174826A1] The present invention relates to the use of closed-pore microspheres of expanded pearlite as a filler for the production of mouldings for the foundry industry, a composition for producing mouldings for the foundry industry comprising closed-pore microspheres of expanded pearlite as a filler and a binder, wherein the binder is selected from the group consisting of sodium silicate, phenol-formaldehyde resins, two-component systems that comprise a polyol component containing free hydroxyl groups (OH groups) and a polyisocyanate as the reactants, and starch, and also mouldings for the foundry industry and a method for producing a moulding for the foundry industry.
