Abstract (en)
[origin: WO2017178086A1] The invention relates to a device (1) for packaging piece good combinations (20) comprising a transport device (3) that transports a plurality of piece goods (10) in a predetermined transport direction (T), comprising a first wrapping device (2) that is designed and intended for wrapping the piece goods (10) with a film element (12), wherein this first wrapping device (2) has an application assembly (30) surrounding the piece goods (10), wherein the piece goods (10) can be supplied to the first wrapping device (2) in order to be wrapped with the film element (12), and comprising at least one separation device (4) which is arranged downstream of the first wrapping device (2) in the transport direction (T) of the piece goods (10), and which separates sections of a piece good flow (S) wrapped in the first film element (12) and/or which facilitates a separation process. According to the invention, the device has a fitting device (8) that provides the piece goods (10) with at least one fitting.
