Abstract (en)

[origin: WO2017180053A1] Method for authenticating a transaction, wherein a first transaction party uses a first electronic device (310,320) with a screen display (311,321) and a second transaction party uses a second, portable, electronic device (410) with a camera. The invention is characterised in the steps a)associating the transaction with the first device and providing there to transaction information; b)displaying, on the screen display, visually coded information identifying the transaction; c)capturing, using the camera, an image of the screen display, which image comprises said coded information and at least a portion of the first device outside of the screen display; d)based upon the captured image, decoding and interpreting said coded information and identifying a piece of first device hardware; e)verifying that the transaction identified by the coded information is associated with the first device, based upon the identified piece of hardware. The invention also relates to a system.
