Abstract (en)  
[origin: WO2017178111A1] The invention relates to a device and a corresponding method for checking value documents (3), in particular banknotes, comprising at least one first sensor (21, 22) which is designed to detect electromagnetic radiation reflected and/or transmitted from a value document (3) and convert the radiation into corresponding first sensor signals, at least one second sensor (24) which is designed to detect soundwaves, in particular ultrasonic soundwaves, reflected and/or transmitted from the value document (3) and convert the soundwaves into corresponding second sensor signals, and an analysis device (51) which is designed to ascertain a first surface value which characterizes a first surface of the value document (3) using the first sensor signals, to ascertain a second surface value which characterizes a second surface of the value document (3) using the second sensor signals, and to draw a conclusion regarding a possible identification of the value document (3) with a marking dye using the first and second surface value. The invention further relates to a value document processing system (1) comprising such a device.
