[origin: CA3026313A1] The invention relates to a sealing string (1, 11) for sealing a joint (21) between two components (22, 23), in particular between two building components, comprising: - a profiled seal (2, 12) with a compressible sealing material; - strip-type lateral portions (51, 52, 19) which project from the profiled seal (2, 12) in different directions, transversely to the longitudinal direction; - a fastening means (6, 20) that is provided on one side of the lateral portions (51, 52, 19) projecting from the profiled seal (2, 12).
