Abstract (en)

[origin: WO2017202950A1] The invention relates to a guide device for a sliding element (3, 4) comprising a guide rail (6) having at least one groove (60, 61) into which a guide element (8, 9, 9') that can be secured to a sliding element (3, 4) can be introduced, wherein the guide element (8, 9, 9') is retained on a holder (10) such that it can be adjusted towards a base of the groove (60, 61) transverse to the longitudinal direction of the guide rail (6) and it can be secured in different positions relative to the base of the groove (60, 61), and an actuation device (20) is provided in order to bring the guide element (8, 9, 9') from a moveable adjustment position into a secured position, wherein the guide element (8, 9, 9') can be moved from a position on the base of the groove (60, 61) away from the base of the groove (60, 61) via the actuation device (20), in order to secure the guide element (8, 9, 9') at a distance from the base of the groove (60, 61). The invention also relates to an item of furniture and a method for assembling a sliding element (3, 4).
