Abstract (en)

[origin: WO2017207894A1] The present invention relates to a method for providing personal information of a user requested by a given online service, the method comprising the implementation, by a data processing module (21) of a security server (2) of a mobile terminal operator (1) of the user, steps of: (a) receiving a request for said personal information of the user, comprising a unique identifier of the user and an identifier of said given online service; (b) sending, to said mobile terminal (1) of the user, a response authorisation request; (c) if a response authorisation confirmation is received, sending data associated with the unique identifier of the user and the identifier of the given online service in a database; characterised in that each pair of a unique identifier and an online service identifier is also associated in said database with a parameter representative of a level of security required in order to confirm the response authorisation on the mobile terminal (1), step (b) comprising: determining the value of said parameter associated in the database with the unique identifier of the user and identifier of the given online service; and integrating the determined value of the parameter in the response authorisation request.
