Abstract (en)

A panel frame structure for a luggage article (100) is provided. The luggage article (100) may include a fabric panel (140) having an outer periphery (210) and a pocket (212) having edges defining an inner periphery (218) defined inwardly from the outer periphery (210), and a frame (178) defining a closed loop corresponding at least partially to the outer periphery (210) of the fabric panel (140). The frame (178) may be received within the pocket (212) unattached to the fabric panel (140) and outwardly biased against the inner periphery (218) of the pocket (212).
