Abstract (en)

The invention relates to a method and a device for packaging sanitary articles such as absorbent articles, like diapers, sanitary napkins, panty liners, incontinence pads or similar, wherein by means of at least one diverter (10) batches (A, B, C, D) of articles (5) are alternately directed towards M packaging arrangements (11, 12), each batch (A, B, C, D) comprising at least one article (5), and wherein the diverter (10) alternately directs batches (A, B, C, D) of articles (5) towards the packaging arrangements (11, 12) in a repeated series of MxN batches (A-C-B-D), with  $N \geq 2$ , wherein at least two of the N batches (A, B) of one series of MxN batches (A-C-B-D) directed towards the first packaging arrangement (11) differ in count.
