[origin: WO2018041568A1] The invention relates to a method and a device for monitoring vehicle states in rail vehicles (10). To this end, data from vehicle-side vehicle monitoring systems (14) and data from a track-side vehicle monitoring system (16) are read, evaluated and error states of a rail vehicle (10) are determined on the basis of the evaluated data.
