Abstract (en)

[origin: WO2018046549A1] The invention relates to a mobile device (10) for protection against firing, said mobile device (10) for protection against firing comprising at least one first supporting element (20) and one second supporting element (20), at least one first plate element (30), and at least one first rail element (40), where the at least first supporting element (20) and the second supporting element (20) can be arranged vertically, where the at least first plate element (30) can be arranged between the first supporting element (20) and the second supporting element (20), where the first rail element (40) can be arranged above the first supporting element (20), the second supporting element (20) and the first plate element (30), where the first supporting element (20) has a first recess (24) for receiving the first plate element (30), where the second supporting element (20) has a first recess (24) for receiving the first plate element (30), where the first supporting element (20) has a first anchoring device (50) on the lower side thereof, where the second supporting element (20) has a second anchoring device (50) on the lower side thereof, where the first supporting element (20) and the first rail element (40) can be non-positively interconnected, and where the second supporting element (20) and the first rail element (40) can be non-positively interconnected.
