Abstract (en)

[origin: CA3035849A1] The invention primarily concerns a facility (1) for storing and cooling a liquefied gas, for example a liquefied natural gas, the facility comprising at least one tank (4) configured to contain the liquefied gas (2), a closed cooling circuit (10) configured to be supplied with liquefied gas (2) in the liquid state coming from the tank (4), at least one injection member (20) configured for re-injecting cooled liquefied gas (2) into the tank, the facility (1) being characterised in that it comprises at least one connection line (31) configured to recover a cooled gas (2) from at least one remote container (100) that is separate and independent from the facility.
