Abstract (en)

[origin: WO2018050575A1] The invention relates to a method for enabling at least one active operating state of a hand-held power tool (14a, 14b, 14c) by means of at least one mobile functional unit (22) according to whether an item of protective equipment (16a, 16b) is carried and/or worn by an operator (21) of the hand-held power tool (14a, 14b, 14c), the mobile function unit (22) being integrated on or in the hand-held power tool (14a, 14b, 14c) and being provided to control an active operating state of the hand-held power tool (14a, 14b, 14c), said method having the following steps: °sending at least one first ID of a first protective equipment element (18a) of a first item of protective equipment (16a) to the mobile functional unit (22), the mobile functional unit (22) receiving the first ID of the first protective equipment element (18a) of the item of protective equipment (16a); °enabling at least one active operating state of a hand-held power tool (14a, 14b, 14c) by means of the mobile functional unit (22) by switching on at least one electric power supply for the hand-held power tool (14a, 14b, 14c).
