[origin: WO2018060373A1] The present invention relates to drugs derived from elafibranor. It relates more specifically to a composition comprising at least one active ingredient, characterised in that at least one active ingredient comprises an elafibranor metformin salt. The present invention also relates to a dual-action elafibranor derivative for treating obesity associated with non-alcoholic steatohepatitis (NASH) and hypertriglyceridaemia.
