[origin: US2019271950A1] A musical watch case including a case middle with surfaces for receiving and supporting a cover with a bezel, and a casing ring, and supporting at least one gong with a resonant part distinct from the walls of the case middle, which supports the cover via distinct and remote lugs included in the bezel or the case middle and which are arranged to allow vibration of the cover, and form, with at least one gasket, the only direct contacts between the bezel and the case middle, which includes, around an annular wall defining an inner chamber around the casing ring, and around all the other these lugs, a resonator ring integral with the case middle distant at every point from the bezel and from the lugs, forming with this wall an external radiating cavity.

Boîte de montre musicale (100) comportant une carrure (10) avec des surfaces (11 ; 14) recevant en appui un couvercle (1) avec lunette (2), et un cercle d'encadrement (4), et portant au moins un timbre (6) avec une partie résonante distincte des parois de la carrure (10), laquelle porte le couvercle (1) par des pattes (7) distinctes et distantes que comporte la lunette (2) ou la carrure (10) et qui sont agencées pour permettre la vibration du couvercle (1), et constituant, avec au moins un joint (102), les seuls contacts directs entre la lunette (2) et la carrure (10), laquelle comporte, autour d'une paroi (16) annulaire définissant une chambre intérieure (17) autour du cercle (4), et autour de toutes lesdites pattes (7), un anneau résonateur (8) solidaire de la carrure (10) en tout point distant de la lunette (2) et des pattes (7), formant avec ladite paroi (16) une cavité rayonnante extérieure (18).
