Abstract (en)  
[origin: WO2018087475A1] The invention relates to a powder-based additive manufacturing unit (10) comprising a device (14) for layering the powder, which can be moved along a path connecting a start zone (A) and an end zone (B). The layering device (14) comprises powder-smoothing means (35) for depositing the powder in a powder deposition zone (P) located between the start zone (A) and the end zone (B). The unit (10) also comprises a cleaning device (60) located on the path of the layering device (14), said cleaning device (60) comprising a brush device (62) for brushing at least one surface of the powder-smoothing means (35).
