Abstract (en)
[origin: US2019037516A1] An embodiment of the present invention relates to a method for performing a registration through a first network access and a second network access by user equipment (UE) in a wireless communication system, the method comprising the steps of: performing a registration through a first network access by UE; and performing a registration through a second network access by the UE, wherein when the first network access and the second network access belong to an identical public land mobile network (PLMN), the UE starts a registration through the second network access only after a registration procedure thereof through the first network access has been completed.
