[origin: WO2018104061A1] The invention relates to a device, to a means of transportation, and to a method for assisting a user of a means of transportation. The method comprises the following steps: analyzing behavior of the user (4) in the operation of the means of transportation (10) and/or constraints of a driving task and, in accordance with a result of the analysis, automatically producing (200) suggestions for software packages to be downloaded.
