[origin: WO2018114030A1] The invention relates to a method for monitoring and/or tracing an individual bank note and a precursor of the bank note in the form of a substrate web or in the form of an individual blank on a bank note sheet during the production process of the bank note, of the precursor, and of the individual blank. According to the invention, an individual feature of the bank note, the precursor, or of the individual blank is detected and saved in a database for possible later query.
