Abstract (en)

[origin: WO2018127546A1] A carrying belt (1) is specified for carrying a video camera or still camera (K) on the body having - a shoulder pad (2), - a belt (3) coupled to the shoulder pad (2) that can be run transversely across the upper body (O) of a user, and - at least one connecting piece (5) for fastening the belt (3) to the video camera or still camera (K) to be carried, which belt is distinguished by a slide (4), via which the belt (3) is coupled to the shoulder pad (2) in such a way that the belt (3) can be moved in the direction of a longitudinal extension of the belt (3) relative to the shoulder pad (2) and is simultaneously secured to the shoulder pad (2) transversely to the longitudinal extension. This solution is a development of a known carrying belt (1) to be worn transversely across the upper body (O) by allowing attachment of a still camera (K) or a video camera to be fastened to the belt at the fittings (R) provided for attaching a classical neck strap or also to one of these fittings (R) and a tripod belt bush (B) on a camera (K) of this kind while at the same time permitting simple and unhindered handling and operation of the camera (K) when attached to the carrying belt (1).
