Abstract (en)
The invention relates to an assembling device and a method for assembling anchor bolts in a concrete reinforcing mesh. Anchor bolts are commonly used fasteners for attaching structures, such as wall elements to a concrete foundation. Unfortunately, assembling anchor bolts in a concrete reinforcing mesh is very laborious and time consuming project. In the present invention, an assembly device for an anchor bolt comprises a fastening part for fastening the assembly device in a concrete reinforcing mesh, and supporting part supporting an anchor bolt in the assembly device, wherein the fastening part and supporting part are connected together in a substantially perpendicular position.
