Abstract (en)
The invention refers to a food handling system having a positioning system, the position system includes: a main conveying surface configured to move food products; an electronic sensor configured to capture position data about one or more food products on the main conveying surface within a sensor range of the sensor; a robot, and a controller which is signal-connected to the electronic sensor and the robot, and configured to instruct the robot to move a food product to a destination position.
