[origin: WO2018178000A1] The invention relates to a method for producing a multilayer film (10), wherein in at least one step at least one ink is applied onto a layer by means of inkjet printing, whereby at least one region of at least a first print (100) is provided and wherein the first print (100) is covered by at least one further layer. The invention further relates to a multilayer film (10), in particular produced by a method according to the invention, comprising at least a first print (100), the print (100) being produced by means of inkjet printing, wherein the print (100) is arranged within the multilayer film (10) and is covered by further layers of the multilayer film (10).
