[origin: EP3607981A1] The present invention relates to a kit for treating or relieving incision site pain. According to the present invention, there is provided a kit for treating or relieving postoperative incision site pain, which makes effective treatment possible by injecting a pain relief drug or a treatment drug into a surgical site after incisional surgery during an incisional surgical procedure, and stably and slowly releasing the drug.
