[origin: WO2018202383A1] A detergent composition comprising from 20 to 80 wt. % of alkali carbonate; and from 1.0 to 10 wt. % of nonionic surfactant; and from 1.0 to 10 wt.% of copolymer comprising: i. monomers containing sulfonic acid groups; ii. further ionic and/or nonionic monomers; and from 0.1 to 9.0 wt. % of a mixture of: a) phosphonates, phosphonic acids or a combination thereof; and b) phosphates, phosphoric acids or a combination thereof.
