[origin: WO2018226667A1] A dressing may include a cover including a non-porous film, a manifold adhered to the non-porous film, a tissue interface including a hydrophobic film adhered to the manifold, and a plurality of fluid restrictions in the hydrophobic film adjacent to the manifold. The cover, the manifold, and the tissue interface each have an exposed perimeter. The dressing may also include an attachment device configured to seal the exposed perimeter of each of the cover, the manifold, and the tissue interface.
