[origin: CA3058103A1] Foldable tent comprising a roof (12) having a tent canvas (14), a first mastless umbrella structure (16), a second mastless umbrella structure (16'), and at least a first junction configured to connect in a hinged manner the distal end (21a) of a first rib (21) of the first umbrella structure and the distal end (21'a) of a first rib (21') of the second umbrella structure, the foldable tent being able to assume a deployed position in which the first and second umbrella structures are in the open position and a folded position in which the first and second umbrella structures are in the closed position.
