Abstract (en)  
[origin: WO2018234700A1] An apparatus for producing a composition comprises a holding device (5) for holding first and second capsules (3, 4) comprising first and second deformable compartments (3.1, 4.1), respectively, which contain a first formulation and a second formulation, respectively; a first compression element (19) comprising a first compression surface designed to apply a pressure to the first deformable compartment (3.1) of the first capsule (3); and a second compression element (21) comprising a second compression surface designed to apply a pressure to the second deformable compartment (4.1) of the second capsule (4). The first compression surface is designed to conduct and guide the contents of the first capsule (3) to a first passage in the first capsule (3) that can be fluidically connected to the first deformable compartment and the second compression surface is designed to conduct and guide the contents of the second capsule (4) to a second passage in the second capsule (4) that can be fluidically connected to the second deformable compartment.
