Abstract (en)  
[origin: WO2019011701A1] The invention relates to cosmetic means for temporarily changing the colour of keratinous surfaces, in particular human hair and human skin, containing a combination of an anionic polymer A and an amphoteric polymer B, as well as at least one pigment. The cosmetic means have an extremely high level of water resistance, yet can be removed without residue with a single application of surfactant-containing cleaning agents. The invention also relates to methods for temporarily colouring keratinous fibres and the skin using this means. Finally, the invention further relates to the use of a combination of anionic polymer A and amphoteric polymer B in pigment-containing cosmetic means for improving the water resistance of this means.
