Abstract (en)

An image capturing apparatus, comprising, an image capturing means for capturing an image, a communication means for communicating with a client and a server via a network, and a processing means for executing first processing for communication with the client and second processing for communication with the server, wherein the communication with the client and the communication with the server include transmission of the image, and after the first processing and the second processing have been started, the processing means stop the first processing when the communication means have established the communication with the server, and does not stop the first processing when the communication means have not established the communication with the server.
