Abstract (en)
An apparatus and method are provided for a finish configured to define an opening to an interior of a container and to substantially reduce foaming of contents when the container is opened, the finish comprising: a cylindrical body (148) comprising a peripheral portion with a first edge (152) and a second edge (156) disposed at opposite ends, the first edge defining a first opening (160) and configured to receive a container cap (164), the second edge defining a second opening (168) and configured to receive a neck (136) of the container, wherein the first and second openings are in fluid communication; one or more threads (176) on an exterior of the peripheral portion, the threads configured to rotatably engage with one or more threads (176) of the container cap (164); and at least one notch (196) disposed at the first edge, peripheral to the first opening, the at least one notch comprising a cross-sectional shape suitably formed to substantially reduce foaming of the contents.
