Abstract (en)  
A flush toilet, comprising: a toilet bowl part with a rim part formed in an upper end part thereof; a first rim water passage formed on an outer peripheral side of the rim part and on one of left and right sides of a toilet body; a second rim water passage formed on the outer peripheral side of the rim part and on the other of left and right sides of the toilet body; a first rim discharge hole through which water is discharged from the first rim water passage into the toilet bowl part; a second rim discharge hole through which water is discharged from the second rim water passage into the toilet bowl part; a spout hole formed in a bottom part of the toilet bowl part or in a drainage passage part connected to the bottom part; and a communication passage that communicates the first rim water passage and the spout hole, wherein: the first rim water passage is formed to be a dead end at a termination end part in the extending direction thereof; the first rim discharge hole is formed to branch off from a midway of a path from a starting end side toward a termination end side of the first rim water passage; and a water introducing port of the communication passage opens closer to the termination end side of the first rim water passage than the first rim discharge hole.
