Abstract (en)
[origin: WO2019043064A1] The invention relates to a composition for topical treatment of non-microorganism-caused inflammatory skin and mucous membrane diseases, such as psoriasis type I and type II, preferably psoriasis vulgaris, psoriasis guttata, psoriasis nummularis, erythrodermal psoriasis, psoriasis pustulosa; in particular neurodermitis, atopic eczema, atopic dermatitis and pytiriasis capitis, wherein the composition contains at least one lysosomotropic antiapoptotically active substance or a substance combination of at least one lysosomotropic antiapoptotically active substance and at least one antioxidatively active substance. A series of compounds can be used as a lysosomotropic antiapoptotically active substance or a substance combination of at least one lysosomotropic antiapoptotically active substance, in particular those which have, as an essential structural element, a basic, aliphatic and protonatable side chain or ring structure, a pKa value between 6 and 8.5 and an n-octanol-water distribution coefficient log P value > 4.0. These can be, for example, benzodiazepine derivatives, phenoxazine derivatives, or annule derivatives, in particular amitriptyline.
