Abstract (en)
[origin: EP3694010A1] An electroluminescent display substrate and a manufacturing method thereof, a display panel and a display apparatus are disclosed. The electroluminescent display substrate (10) includes: a base substrate (100) including a display area (101) and a peripheral area (102) surrounding the display area (101), wherein at least one OLED device (20) is in the display area (101); a pixel defining layer (204) in the display area (101) and the peripheral area (102); at least one groove (300) in the pixel defining layer (204) in the peripheral area (102); wherein the at least one OLED device (20) has a first electrode (201), the first electrode (201) is on a side of the pixel defining layer (204) away from the base substrate (100) and extends to cover the groove (300).
