Abstract (en)
A food supplementation vessel (200), comprising,- a vessel body (204, 206) adapted to store a liquid;- an opening (214) through which liquid can flow out of the vessel body (204, 206);- a first septum (216) closing the opening (214);- a second septum (220) arranged spaced apart from the first septum (216) and opposite to the opening (214); and- a use indicator (232) coding element representing a use indicator of the food supplementation vessel;- wherein the cap (210) comprises at the circumferential surface at least two mechanical coding elements (230) indicating a type of the food supplementation vessel.
