Abstract (en)

[origin: WO2019110807A1] The invention relates to a processing machine, in particular a printing machine, comprising a unit having a storage container, and method for operating a storage container in a unit of a processing machine, in particular a printing machine, wherein the storage container comprises a roller (01) and a base (03) which delimit a storage chamber (04) for a medium, and wherein one or more sliders (06) are arranged along an edge of the base (03) to form, together with the roller (01), an outlet gap (13) for the medium. The invention is based on the problem of creating alternative processing machines having a unit and an alternative method for operating a storage container in a unit, more particularly a printing unit, of a processing machine. According to the invention, the problem is solved in that in the region of the slider(s) (06), pneumatic means are provided to seal the supply chamber (04) with respect to the medium.
