[origin: WO2019110871A1] The present invention relates to a composite pigment composition which comprises titanium dioxide and at least one precipitated porous pigment. The invention also relates to the use of such a composite pigment composition as a pigment providing opacity and brightness. Further, the invention relates to the use of the composite pigment composition according to the invention as a titanium dioxide substitute without impairment of the optical properties.
