Abstract (en)
The object of the invention is a fixed system for protection against falls from height, comprising a steel rope of a horizontal system positioned substantially parallel to the roof surface characterised in that it comprises a steel rope of a vertical system, whose upper segment is fixedly connected to one of the posts of the horizontal system, the steel rope of the horizontal system being fixedly situated above the roof level by means of at least two posts of the horizontal system.
