Abstract (en)
A lighting apparatus (1) provided with a light source (20) having a directed light beam, comprising a lamp body (10) extending along a longitudinal axis X, in which body the light source (20) is housed and which is supported by a support (50). The lighting apparatus (1) is characterized in that the lamp body (10) is fixed to the support (50) by means of a releasable tensioning system, which is operable between a locked configuration in which the lamp body (10) cannot rotate with respect to the longitudinal axis (X), and a released configuration in which the lamp body (10) can rotate with respect to the longitudinal axis (X).
