[origin: WO2019122158A1] The present invention relates to a cosmetic composition in the form of an emulsion comprising: • at least 10% by weight of water, relative to the weight of the composition; • at least 10% by weight, relative to the weight of the composition, of at least one silicone resin; • at least one amino silicone oil; • optionally at least one non- volatile silicone oil; • optionally at least one non-volatile silicone oil, free of (poly)glycerol and (poly)oxyalkylene groups, the oxyalkylene group being C2-C3; • the content of amino silicone oil being at least 4%> by weight, relative to the weight of the composition if said composition does not comprise any non- volatile silicone oil(s). The invention also relates to a process for making up and/or caring in particular for the keratin materials, for instance the skin, the lips and preferably the lips, in which the abovementioned composition is applied.
