Abstract (en)

[origin: EP3730196A1] The present technology relates to an information processing apparatus, an information processing method, and a program, suitable for appropriately recognizing rhythm of motion of a user. The information processing apparatus includes a motion rhythm recognizing unit configured to recognize motion rhythm indicating rhythm of motion of a user on the basis of detection data detected by a sensor apparatus at one or more detection positions including at least one portion on a body trunk of the user, the detection data indicating motion of the detection positions. The present technology can be applied, for example, to a production system that produces performance.
