Abstract (en)  
[origin: WO2019166205A1] The invention relates to a piece of furniture or domestic appliance comprising: a body (2); at least one drawer element (3), which is slidably arranged in the body (2) and has two side walls (4), respective pull-out guides (5) being arranged between the side panels (4) and side walls (21, 22) of the body (2), each of the pull-out guides (5) having at least one body rail (51) which can be fastened to a side wall (21, 22) of the body (2) and one running rail (52) which can be fastened to the side panel (4); and at least one functional unit (6), which is coupled to one of the pull-out guides (5), wherein in at least one of the side walls (4) a functional unit (6) arranged at distance from the pull-out guide (5) is detachably arranged, which functional unit, in a predefined position of the drawer element (3) relative to the body (2), is operatively connected to a counter-element (7, 15) stationarily mounted on the body (2) or on the body rail (51). The invention further relates to a method for mounting a functional unit (6) of a drawer element (3) in a piece of furniture or domestic appliance.
