Abstract (en)

[origin: WO2019179927A1] The invention relates to a method for interaction between at least one user and/or at least one first electronic device (2, 100) comprising at least one processor or microprocessor or a graphics processing unit called a GPU, a memory, an input/output port allowing the transmission of data to and from said electronic device and a display screen, and a second electronic device (1) comprising at least one processor or microprocessor or a graphics processing unit called a GPU, a memory, an input/output port allowing the transmission of data to and from said second electronic device (1) and a tactile display screen. Said method is characterised in that it comprises at least the following steps of: connecting at least one user and/or a first electronic device (2, 100) to the second electronic device (1), and generating a first graphical user interface, called a main GUI (3), on the tactile screen of the second electronic device (1) for each user and/or each first electronic device (2, 100) connected to said second electronic device (1).
