Abstract (en)

[origin: WO2019193296A1] The invention relates to a method for processing a transaction between a source terminal and a destination terminal implementing a transaction phase comprising: - receiving (31), by a source BTS connected to the source terminal, a transaction request originating from the source terminal, said request carrying at least one identifier of said destination terminal and a transaction amount; - obtaining (32), by the source BTS, destination terminal location information, on the basis of at least one location database, denoted BLDB, and said destination terminal identifier; - determining (33), by the source BTS, at least one destination BTS connected to the destination terminal, on the basis of said destination terminal location information; and - transmitting (35), to said destination terminal and by the destination BTS, said request or information relating to said transaction.
