Abstract (en)

[origin: WO2019219476A1] The invention relates to a barrel module (10) for a barrel (20) having at least one first weapon (30) and one second weapon (32), wherein: the barrel module (10) can be completely introduced into the barrel (20) and completely removed from the barrel (20); the barrel module (10) has at least one first storage region (40); the at least one first storage region (40) has at least one first first storage position and one second first storage position; the first first storage position and the second first storage position are each designed to receive a weapon (30, 32); the first first storage position and the second first storage position are arranged one behind the other in the longitudinal direction of the barrel module (10); the first weapon (30) is arranged in the first first storage position; the second weapon (32) is arranged in the second first storage position; the barrel module (10) has at least one first secondary region (50); the at least one first secondary region is arranged in the transverse direction of the barrel module (10) adjacent to the at least one first storage region (40); a first connection apparatus (60) is arranged behind the first weapon (30) in the at least one first storage region (40); the first connection apparatus (60) can be moved from the at least one first storage region (40) into the at least one first secondary region (50).
