Abstract (en)
[origin: CN112540528A] Disclosed is a sub-assembly (100) of external parts. The sub-assembly comprises a fastening part (3). The fastening part, a first component and a second component are coaxially arranged and compressing together a sealing and friction joint (9), and interposed therebetween. The fastening part axially limits the first component (1) to fix the first component and the second component. In an assembly position, the lower surface of the fastening part is located near the upper surface (28) of the second component (2). The fastening part comprises a lower concave and convex part (41) protruding axially to the second component (2) from the lower surface (38). The lower concave and convex part (41) is arranged to complementarily match a long groove (26) in a revolutionary mode included in the uppersurface (28) or to protrude from the upper surface (28) of the second component (2) toward an angular lock part of an upper concave and convex part axially extending the fastening part. The long groove (26) is interrupted by the lock part (27) which limits angular stroke between the second component (2) and the fastening part within a certain range.
