Abstract (en)  
[origin: WO2019224497A1] The invention relates to a method for preparing the upper surface (40) of an additive manufacturing platen (24) by depositing a bed of powder, the method comprising at least one step consisting in increasing the roughness of at least one area of the upper surface of the platen by printing a pattern (M) in this area. According to the invention, the pattern is printed inside the additive manufacturing machine (10) by depositing a bed of powder in which the platen is then used for additive manufacturing using the powder bed deposition process.
