Abstract (en)

[origin: WO2020003199A1] A drawer (20) adapted to contain a group (6) of smoking articles and a collar (9); the drawer (20) has a pocket (24), which has a tubular shape and a rectangular cross-section, is adapted to house the group (6) of smoking articles and the collar (9), and has a first opening (25), through which the group (6) of smoking articles can be inserted, and a second opening (26) opposite to the first opening (25), through which the group (6) of smoking articles and the collar (9) can to be extracted from the drawer (20) together. At least one wall (27) of the pocket (24) has a step (31), which is arranged close to the first opening (25), locally reducing the size of the pocket (24), and has a thickness equal to at least the corresponding thickness of the collar (9).
