Abstract (en)
[origin: WO2020006589A1] The invention relates to a furniture fitting (4) for the movable mounting of a furniture part (3) movably mounted relative to a furniture body (2), comprising: a first fitting part (5) for fixing to the furniture body (2), a second fitting part (6) for fixing to the movable furniture part (3), wherein the two fitting parts (5, 6) are pivotally connected to each other by at least one joint axis (33a, 33b, 17a), and the first fitting part (5) is designed to be inserted at least partly into a recess (15a) in the furniture body (2) and/or the second fitting part (6) is designed to be inserted at least partly into a recess (15b) in the movable furniture part (3), wherein the first and/or second fitting part (5, 6) has an elongated housing (6a, 8a) having two end regions (31a, 31b) spaced apart from each other in the longitudinal direction (L), wherein the at least one joint axis (33a, 33b, 17a) is arranged in a first end region (31a) of the housing (6a, 8a), wherein the first and/or second fitting part (5, 6) has a fixing device (32) having at least one movably mounted actuating element (32a) in the form of a rotatable screw, wherein, by means of an actuation of the at least one actuating element (32a), the first and/or second fitting part (5, 6) can be fixed in the recess (15a, 15b) in both end regions (31a, 31b) of the housing (6a, 8a).
