Abstract (en)

[origin: CN112828948A] The invention relates to a razor (1) comprising a handle (2) and a head (3) which is pivotably arranged on the handle (2), the head (3) having a frame (7) and a cover (15), and at least one razor blade (13) which has a cutting edge and which is supported between the frame (7) and the cover (15). The razor is characterized in that the razor blade (13) is pivotably arranged on the handle (2). The at least one wiper blade (13) is mounted in a replaceable manner between the frame (7) and the cover part (15), the at least one wiper blade (13) can be inserted between the frame (7) and the cover part (15) by means of an actuatable fastening member (16, 17, 18, 19), and the fastening member (16, 17, 18, 19) is arranged close to a side edge of the at least one wiper blade (13) relative to a cutting edge of the at least one wiper blade (13).

Ein Rasierer (1) mit einem Griff (2) und einem schwenkbar an dem Griff (2) angebrachten Kopf (3), wobei der Kopf (3) einen Rahmen (7) und eine Abdeckung (15) aufweist, und mindestens eine Rasierklinge (13), die eine Schneidkante aufweist und zwischen dem Rahmen (7) und der Abdeckung (15) gelagert ist, wobei die mindestens eine Rasierklinge (13) auswechselbar zwischen dem Rahmen (7) und der Abdeckung (15) gelagert ist, die mindestens eine Rasierklinge (13) mittels betätigbarer Fixiermittel (16, 17, 18, 19) zwischen dem Rahmen (7) und der Abdeckung (15) einsetzbar ist, und die Fixiermittel (16, 17, 18, 19), bezogen auf die Schneidkanten der mindestens einen Rasierklinge (13), nahe den Seitenkanten der mindestens einen Rasierklinge (13) angeordnet sind.
